That the school will not open classes under CBSE pattern particularly class 6 IX/X/XI/XII and will not use CBSE name in any manner without obtaining Affiliation.

That the Principal and Correspondent/Manager of the school have individually gone 7 through the provisions contained in the affiliation & examination byelaws and the circulars issued by the Board from time to time. The school undertakes to abide by the provisions contained in the affiliation & examination byelaws, directions issued from time to time and the law of the land.

That the school will ensure compliance of all statutory requirements like EPF, ESI 8 and Labour Laws etc. with respect to the school and staff of the school.

That the school will ensure that the Building Safety, Fire Safety, Water Safety, Health and Hygiene certificates are being issued or renewed by the concerned municipal or state authorities from time to time as per the prescribed term.

That the school will ensure that all required infrastructure is available with the 10 School before starting classes.

That the school will ensure that sufficient number of qualified teachers as per the 11 Provisions contained in affiliation bye-laws are available with the school before starting classes.

That the school will follow the provisions related to fee contained in affiliation bye-12 laws and will disclose the details of the fee to the students/parents every year before start of session without resorting to any hidden charges in the heads of the

State Pattern classes IX to XII will be closed in a phased manner. No admission will be taken in the State Board Pattern Class IX to XII after getting affiliation from CBSE. The State Board School will be discontinued after switchover to CBSE.
